Unusual Fire and Hazardous Combustion and Decomposition Products: Smoke, soot, and toxic/irritating fumes (i.e., carbon dioxide, carbon monoxide, etc.). Oxides of nitrogen and carbon.

Fire and Explosion Hazards: May liberate irritating or toxic vapors during combustion or decomposition.

Extinguishing Media: Based on the NFPA guide, use dry chemical, carbon dioxide, water mist, water jet sprays, halogen, or alcohol foam suitable for Class B fires.
