Primary Routes of Exposure:

Section 5: Fire-Fighting Measures

Extinguishing Media: Based on the NFPA guide, use dry chemical, carbon dioxide, water mist, water jet sprays, halogen, or alcohol foam suitable for Class B fires. Use water to cool containers exposed to fire. For large fires, use water spray, fog or alcohol foam, thoroughly drenching the burning material.

Unsuitable Extinguishing Media: High volume water with full jet. Oxidizers and reducers.

For larger spills, transfer to a salvage tank for safe recovery/disposal. Residues are treated as small spills.
