### Section 4: First-Aid Measures

**Primary Routes of Exposure:**

### Section 5: Fire-Fighting Measures

**Extinguishing Media:** Based on the NFPA guide, use dry chemical, carbon dioxide, water mist, water jet sprays, halogen, or alcohol foam suitable for Class B fires. Use water to cool containers exposed to fire. For large fires, use water spray, fog or alcohol foam, thoroughly drenching the burning material.

**Unsuitable Extinguishing Media:** High volume water with full jet. Oxidizers and reducers.
